The scope of this ISO/IEC 27017:2015 certification is as follows:

Nextthink cloud-based digital employee experience management SaaS solution including all product components as well as the services used to deliver these applications. Nextthink Products share the same common control framework.

The departments in scope include Product management, Engineering, Technical services, Finance, People & talent (HR), Information Technology, Legal, Sales operations and Security.

The Information Security Management System is centrally managed out of Centre Malley-Lumières, Chemin du Viaduc 1, 1008, Prilly, Switzerland. The scope mentioned above applies to the following locations:

- ▶ Lausanne: Centre Malley-Lumières, Chemin du Viaduc 1, 1008, Prilly, Switzerland with approximately 300 people
